**20a. How does the Committee accomplish its purpose?**

The Board's specific purpose, as outlined by statutory mandate, is to make recommendations to the Assistant Secretary for Energy Efficiency and Renewable Energy (EERE) with respect to (1.a) the energy efficiency goals and objectives of programs carried out under Parts D and G of the Energy Policy and Conservation Act and under part A, Title IV of the Energy Conservation & Production Act; (1.b) to make administrative and policy recommendations to improve these programs, including actions that should be considered to encourage non-Federal resources (including private resources) to supplement Federal financial assistance; (2) to serve as a liaison between the states and the Department of Energy on energy efficiency and renewable energy resource programs; (3) to encourage

transfer of the results of the energy efficiency and renewable energy activities carried out by the Federal Government; and (4) to submit an annual report to the Secretary and Congress on the activities carried out by the Board in the previous fiscal year. The Board also provides advice to the Assistant Secretary on a range of other topics, one of them being technology transfer issues. The STEAB accomplishes its purpose in several ways. The Board meets in person two to three times a year to discuss major issues, goals, initiatives, and challenges facing state and local governments where DOE's programs and efforts play a helpful role in overcoming barriers and facilitating progress. All meetings of STEAB's full membership are open to the public and announced in the Federal Register. The meetings are comprised of members of the Board, DOE staff, and occasionally invited parties from other agencies or organizations. Additionally, the Board conducts monthly open teleconference calls which allow them to stay informed on issues-of-interest, and also creates a forum for discussion about policy changes, state and local program updates, and allows for discussion of other significant issues affecting energy efficiency and renewable energy programs. For the Board meetings, committee members spend substantial time preparing and analyzing issues for discussion. From these meetings, recommendations are proposed, voted on by the Board, and ultimately submitted to the Assistant Secretary.

**20b. How does the Committee balance its membership?**

By Statute, Board membership ranges from no less than 18 members, to no more than 21 members, all of whom are appointed by the Secretary of Energy. Membership regulations are

outlined in Public Law 101-440, Section 5 as follows: At least eight (8) members shall be Directors of the state office responsible for developing state energy conservation plans pursuant to Section 362 of the Energy Policy and Conservation Act, and at least four (4) members shall be directors of state or local low-income weatherization assistance programs. Other members shall be persons who have experience in energy efficiency or renewable energy programs from the private sector, consumer interest groups, utilities, public utility commissions, educational institutions, financial institutions, local government energy programs or research institutions. Other members may include state, local, county, and city government officials who meet one of the statutory categories. A majority of the members of the Board shall be state employees. The members of the Board are appointed for a three-year term, with one-third of the total terms expiring each year. The Board, as mandated, shall be non-partisan. The committee balances its membership by looking for representation from states in different geographic locations. The Committee also balances its membership by appointing women and minorities.

#### **20c. How frequent and relevant are the Committee Meetings?**

The Board meets two to three times per year in open public meetings. At least one meeting every year is held in Washington, D.C. Aside from the full Board Meetings, the Board also conducts monthly open teleconference calls to maintain continuity of its discussions and develop recommendations for the Assistant Secretary. The aforementioned meetings and teleconferences allow the Board to maintain an on-going dialogue of timely efforts relating to EERE programs,

technology transfer, and state issues.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

STEAB is comprised of individuals who bring together unique perspectives and expertise relating to public and private sector energy issues from both state and local vantage points. It is a formal, continuing, statutory body which provides advice to the Assistant Secretary for EERE. It represents an important group of energy efficiency and renewable energy constituencies in a more regular and involved way than ad hoc stakeholder groups convened for a single purpose. STEAB is unlike other FACA committees within EERE as it is not program specific, and therefore can advise and make recommendations to the Assistant Secretary on all EERE technology and policy endeavors. The Board offers a forum for the exchange of ideas and information through which Federal, state, and local voices can be heard at the Department of Energy, thus offering invaluable information to the Assistant Secretary to inform ways in which the Department can effectively accelerate the progress of Federal, state, and local energy efficiency and renewable energy initiatives. With significant EERE funds directed annually to state and local governments and tribal entities, input from the state and local community is essential and STEAB offers a mechanism for receiving direct feedback from state and local energy experts. The dialogue STEAB opens between EERE and state and local entities transforms otherwise grantor-grantee relationships into a set of partnerships that are critical to achieving America's clean energy future.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

All STEAB meetings and teleconference calls are open to the public and have never been closed or partially closed.

## **21. Remarks**

The State Energy Advisory Board was established by Public Law 101-440 (The State Energy Efficiency Programs Improvement Act of 1990) to advise the Department of Energy on operations of its Federal grant programs. The Board's statutory charge is to develop recommendations regarding initiation, design, evaluation, and implementation of energy efficiency and renewable energy programs, policies, and technologies. The Board is legislatively mandated to advise and make recommendations to the Secretary of Energy, through the Assistant Secretary for Energy Efficiency and Renewable Energy (EERE), on efforts relating to EERE programs, with a specific focus on technology transfer and state issues. STEAB did not have any activities in FY 23 due to administrative matters.
