**20a. How does the Committee accomplish its purpose?**

Section 402(b)(9) of the Public Health Service Act states that “the Director, NIH...shall assure that research at...the National Institutes of Health is subject to review in accordance with section 492.”

Section 492(b) states that the “Director of NIH shall establish procedures for periodic technical and scientific peer review of research at the National Institutes of Health. The mission of the Board of Scientific Counselors is to assess the quality of the Institute’s intramural research programs and to evaluate the productivity and performance of intramural scientists and shall

also, as requested by the Director, NIH, undertake peer review of extramural funding applications as required by section 492 of the Public Health Service Act, as amended.” The Board is composed of scientific and technical experts. The Board of Scientific Counselors, National Institute on Alcohol Abuse and Alcoholism continues to provide indispensable evaluation and advisory functions in the science management of the intramural research programs. Each major program area of the Division of Intramural Clinical and Biological Research is reviewed at least once every four years. Besides the formal meetings for peer review of each laboratory, the chair and individual Board members are frequently consulted for advice on staff appointments and program developments.

**20b. How does the Committee balance its membership?**

The Board consists of approximately ten members who are outstanding authorities knowledgeable in the specialized fields of medical sciences, psychology, biochemistry, physiology, pharmacology, the neurosciences, and related clinical fields relevant to the intramural research activities of the Institute. The advisory role of the Board is scientific and substantive. The Board, through periodic visits to the laboratories, assesses the research in progress and evaluates productivity and performance of staff scientists.

**20c. How frequent and relevant are the Committee Meetings?**

This Board met once on September 13-14, 2023. The Board holds one meeting each year for the peer review of intramural laboratories on a rotating basis as required by the PHS Act. During this reporting period, on September 13-14, 2023, the

Board reviewed employees in the Laboratory for Integrative Neuroscience (LIN); Laboratory of Behavioral and Genomic Neuroscience (LBGN); Section on Neural Circuits (SNC); Laboratory of Biophotonics and Quantum Biology (LBQB); and Laboratory on the Neurobiology of Compulsive Behaviors (LNCB). The Board issues a written evaluation on each scientist reviewed. The Board Chair provides to the National Advisory Council on Alcohol Abuse and Alcoholism an oral report of the review and the Board's recommendations.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

This Board is composed of recognized biomedical and/or behavioral research authorities from outside the NIH in order to secure unbiased and objective evaluation of intramural research programs. Their recommendations are invaluable because the complex nature of research in each laboratory requires a unique balance and breadth of expertise not available from the NIH staff or from other established resources.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

The meeting of the Board of Scientific Counselors, National Institute on Alcohol Abuse and Alcoholism, was closed for the review, discussion, and evaluation of individual programs and projects conducted by the Institute, including consideration of personnel qualifications and performance, the competence of individual investigators, and other personal information. Section 552b(c)(6) of the Government in the Sunshine Act permits the closing of meetings where discussion could reveal personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.

## 21. Remarks

Committee Function: Other - Scientific and Technical Peer Review. Reports: This committee did not produce any public reports. Members Rotating Off/Vacancies: One member rotated off (Dr. Christopher Evans). There are 2 vacancies. Members: Dr. Harriet deWit was reappointed as Chair for the committee for an additional year. As such her term of service end date is different than what was reported on the 2022 ACR report. The term for Dr. Harrier deWit is longer than the charter allows due to her reappointment to the BSC given her specific scientific expertise and the need to assure continuity in the functions of the BSC and the review of Laboratories/Branches/Sections by the Board. Designated Federal Officer (DFO): The DFO for the BSC changed in FY23 and has been reflected in the ACR. Based on the assignment of responsibilities within the Institute, the role of committee designated federal officer and committee decision maker are held by the same individual.

All recommendations by the BSC will be fully implemented although the length of time will vary for each scientist. For example, a tenure track scientist, who is not recommended for tenure at NIH will be extended 6 months to 1 year before termination is final. This gives the scientist an opportunity to complete projects and search for a new position outside of the intramural program. Thus, the recommendations of the BSC are partially implemented in the first few months after the review, and fully completed at later date.
