**20a. How does the Committee accomplish its purpose?**

Section 402(b)(9) of the Public Health Service Act states that ...the Director, NIH...shall assure that research at...the National Institutes of Health is subject to review in accordance with section 492. Section 492(b) states that the Director of NIH shall establish procedures for periodic technical and scientific peer review of research at the National Institutes of Health. This Board assesses the quality of the Institute intramural research programs and evaluates the productivity and performance of staff scientists, necessary functions for the operation of a highly effective

intramural research program. The Board is composed of recognized biomedical and or behavioral research authorities who represent the forefront of research and technical knowledge and who provide evaluation and peer review of Institute laboratories and staff scientists in the following areas: diabetes, endocrinology, and metabolism; digestive diseases and nutritional disorders; and kidney, urologic and hematological diseases. The Board continues to provide indispensable evaluation and advisory functions in the science management of the intramural research programs. The Board normally holds two formal meetings each year for peer review of each laboratory and the chairman and individual Board members are frequently consulted for advice on staff appointments and program development. In 2023, two meetings were held; one in October 2022 and the other in March 2023. During the October 14, 2022 meeting, the board reviewed the following labs: Laboratory of Biological Modeling and Laboratory of Endocrinology and Receptor Biology. During the March 27, 2023 meeting, the board reviewed: Digestive Disease Branch, Diabetes, Endocrinology, & Obesity Branch, Laboratory of Biochemistry & Genetics, Laboratory of Cell & Molecular Biology, Laboratory of Endocrinology & Receptor Biology and Metabolic Diseases Branch. During the Spring 2023 session, the board reviewed the work of fifteen (15) Principal Investigators and two (2) tenure track Investigators. The Board provides to the National Diabetes and Digestive and Kidney Diseases Advisory Council for review a description of its activities.

**20b. How does the Committee balance its membership?**

The Board consists of eight members,

approximately, who are outstanding authorities knowledgeable in the specialized fields of diabetes, kidney diseases, molecular biology, chemistry, chemical physics, genetics, endocrinology, biochemistry and nutrition. The advisory role of the Board is scientific and substantive. The Board, through periodic visits to the laboratories, assesses the research in progress and evaluates productivity and performance of staff scientists.

**20c. How frequent and relevant are the Committee Meetings?**

The Board met twice during this reporting period. The Board holds approximately two meetings each year for the peer review of intramural laboratories on a rotating basis as required by the PHS Act.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

The Board is composed of recognized biomedical research authorities from outside the NIH in order to secure unbiased and objective evaluation of intramural research programs. Their recommendations are invaluable because the complex nature of research in each laboratory requires a unique balance and breadth of expertise not available on the NIH staff or from other established resources.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

The meetings of the Board were partially closed for the review, discussion, and evaluation of individual programs and projects conducted by the Institute, including consideration of personnel qualifications and performance, the competence of individual investigators, and similar items, the

disclosure of which would constitute a clearly unwarranted invasion of personal privacy. Section 552b(c)(6) of the Government in the Sunshine Act permits the closing of meetings where discussions could reveal personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.

## 21. Remarks

Committee Function: Other - Scientific and Technical Peer Review. Reports: This committee did not produce any reports during this reporting period. Note that the Designated Federal Officer and Committee Decision Maker positions are both held by the Scientific Director of the Institute. The Board advises the Institute on issues associated with the Institute's Intramural Research Program, which is the primary responsibility of the Scientific Director. Dr. Jay Horton is the chair and will occupy the position until his term ends on 6/30/2024. No members retired in 2023.
