PubMed Central is an archive for the full-text of peer reviewed literature in the life sciences, as well as reports that have been screened but not formally peer-reviewed. The Committee was charged to establish criteria to certify groups submitting materials to the system, monitoring the operation of the system, and ensured that PubMed Central evolved and remained responsive to the needs of researchers, publishers, librarians, and the general public.

Members of this Committee were drawn from expert scientists, life sciences publishers, members of learned societies, medical library and information specialists, and the general public.

## 20c. How frequent and relevant are the Committee Meetings?

The PubMed Central committee did not meet in FY 2018, and will not have any future meetings.

# 20d. Why can't the advice or information this committee provides be obtained elsewhere?

Since the mission of the NIH is to conduct and support medical research and to disseminate the results of that research widely to the public and the scientific community, it made use of electronic publishing technology to fulfill this role by maintaining PubMed Central. This Web-based repository archives, organizes, and distributes peer-reviewed reports from journals in the life sciences. The recommendations of the committee could not be obtained from other sources because of the nature of the issues which requires a specialized balance and breadth of expertise not available from the NIH Staff or from other established sources.
