**20a. How does the Committee accomplish its purpose?**

The Committee provided advice to the Commissioner of Food and Drugs and to other appropriate officials on emerging food safety, food science, and nutrition issues. In addition, the committee recommended ways of communicating to the public potential risks associated with these issues and approaches that may be considered in addressing the risks.

**20b. How does the Committee balance its membership?**

The Committee included a wide range of scientific and technical expertise drawn from different geographical locations throughout the country and strives to include minority and female

representation. The committee also included technically qualified members who are identified with consumer interests and non-voting representatives who are identified with industry interests.

**20c. How frequent and relevant are the Committee Meetings?**

The committee met only five times in the last nine years.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

Members of the Committee were drawn from academia, research organizations, state health departments and clinical practice. Their advice and input lends credibility to FDA's regulatory decisions. The alternate means of obtaining this advice would involve the recruitment of a large number of scientists on a full-time basis at maximum rates of compensation.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

There were no closed meetings to report in FY18.

**21. Remarks**

In view of the declining number of issues for which the FAC is determined to provide the most appropriate input to the Center, and the infrequent meetings held by this Committee, it was deemed that the effort and expense of maintaining this advisory committee is no longer justified. In recent years, the FAC has been convened solely to advise FDA on food safety policies, with other mechanisms being used to provide input into the Center on topics such as nutrition. Its most recent meeting in December 2015, discussed FDA's

policies related to the presence of *Listeria monocytogenes* in foods. CFSAN has determined that any relevant FAC issues in the future can be addressed by the Agency's other advisory committees, such as the FDA Science Board and the FDA's Risk Communication Advisory Committee (RCAC), with additional augmentation of expertise by appropriate subject-matter experts serving as temporary members of those committees. In addition, CFSAN will continue to hold public meetings, webinars, workshops, and conferences to engage with stakeholders. The existing members of the FAC will be retired as special government employees. The committee was terminated on December 12, 2017. The committee had no expenditures this year and less than 10% of a staff year was dedicated to terminating it in December 2017.
