20a. How does the Committee accomplish its purpose?

Section 492 of the PHS Act states that The Secretary...shall by regulation require appropriate technical and scientific peer review of -- (A) applications...; and (B) biomedical and behavioral research and development contracts. This committee is composed of recognized biomedical and behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research grant applications and/or contract proposals in the areas of basic and clinical aspects of metabolic, nutritional and gastroenteric processes in normal and disease states and will review training activities in clinical science. During this reporting period the committee reviewed 761 applications requesting \$1,529,430,157.00.

20b. How does the Committee balance its membership?

The members of this committee are authorities knowledgeable in the areas of basic and clinical aspects of metabolism, nutrition and gastroenterology including, but not limited to, metabolic studies in normal and disease states at the organism, tissue or cellular level, the requirements of living organisms for nutrients, vitamins and trace elements as well as nutritional

practices, gastroenterology and training grants in clinical sciences.

20c. How frequent and relevant are the Committee Meetings?

The committee held 12 meetings during this reporting period.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

This committee is composed of recognized biomedical and/or behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research grant applications and contract proposals. These evaluations and recommendations cannot be obtained from other sources because the specialized, complex nature of the applications and proposals requires a unique balance and breadth of expertise not available on the NIH staff or from other established sources.

20e. Why is it necessary to close and/or partially closed committee meetings?

The meetings of the committee was closed to the public for the review of grant applications. Sections 552b(c)(4) and 552b(c)(6) of the Government in the Sunshine Act permit the closing of meetings where discussion could reveal confidential trade secrets or commercial property such as patentable material and personal information, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.

21. Remarks

This committee did not produce any public reports

during the fiscal year. Due to the assignment of responsibilities within the Center, the roles of the committee designated federal official and committee decision-maker are filled by the same individual. The following members' terms ended early: Drs. Felix Yichung Feng (08/07/2023) and Karl D Wittrup (07/01/2023). Drs. Michael Archibald Farrar and Eun-Sil Shelley Hwang's roles changed to chairperson during the fiscal year. Dr. Michael Farrar's term will end two years earlier (6/30/2025).
