This committee is composed of recognized biomedical and behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research grant applications and/or contract proposals in the fields of basic clinical and pharmacologic aspects of the cardiovascular, renal and hematologic systems in normal and disease states. During this reporting period the committee reviewed 1,768 applications

# 20b. How does the Committee balance its membership?

The members of this committee are authorities knowledgeable in the fields of basic, clinical and pharmacologic aspects of the cardiovascular, renal and hematologic systems in normal and disease states including, but not limited to studies of coronary artery and myocardial disease, cardiac function, hemodynamics, blood pressure regulation, hematology and studies of cardiovascular drugs.

The committee held 24 meetings during this reporting period.

# 20d. Why can't the advice or information this committee provides be obtained elsewhere?

This committee is composed of recognized biomedical and/or behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research grant applications and contract proposals. These evaluations and recommendations cannot be obtained from other sources because the specialized, complex nature of the applications and proposals requires a unique balance and breadth of expertise not available on the NIH staff or from other established sources.

# 20e. Why is it necessary to close and/or partially closed committee meetings?

The meetings of the committee was closed to the public for the review of grant applications.
