Section 492 of the PHS Act states that The Secretary shall by regulation require appropriate technical and scientific peer review of (A) applications; and (B) biomedical and behavioral research and development contracts. This committee is composed of recognized biomedical and/or behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research grant applications and/or contract proposals in the fields of maternal and child health, reproductive and

population sciences, intellectual and developmental disabilities, and medical rehabilitation. During this reporting period, the committee reviewed 443 applications requesting \$196,610,044.

20b. How does the Committee balance its membership?

The members of this committee are authorities knowledgeable in the various disciplines and fields relating to maternal and child health, reproductive and population sciences, intellectual and developmental disabilities, and medical rehabilitation.

20c. How frequent and relevant are the Committee Meetings?

The committee held 24 meetings during this reporting period.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

This committee is composed of recognized biomedical and behavioral research authorities who represent the forefront of research and technical knowledge and who provide first-level merit review of highly scientific and technical research grant applications and contract proposals. These evaluations and recommendations cannot be obtained from other sources because the specialized, complex nature of the applications and proposals requires a unique balance and breadth of expertise not available from the NIH staff or from other established sources.

20e. Why is it necessary to close and/or partially closed committee meetings?

The meetings of the committee were closed to the

public for the review of grant applications. Research grant applications submitted to NIH must go through a two-step review process that includes the initial peer review for scientific and technical merit and a second step of review and approval by a National Advisory Council for program relevance. In addition, prior to an award or funding being made, NIH staff must conduct an administrative review for a

number of other considerations. These include alignment with NIH's funding principles, review of the project budget, assessment of the applicant's management systems, determination of applicant eligibility, and compliance with public policy requirements. After all these steps have been completed, NIH officials make funding decisions on individual grant applications.
