20a. How does the Committee accomplish its purpose?

The Center for Mental Health Services (CMHS) National Advisory Council accomplishes its purpose through advising, consulting with, and making recommendations to the Director, CMHS, concerning activities and policies related to responding to the service needs of Americans with mental illness. The Council also accomplishes its purpose by providing a secondary review of summary statements of grant applications for which Council approval is required under Section 504(c)(2) of the Public Health Service Act. The Council recommends for approval those applications that showed promise of making valuable contributions to the Center's mission. In fiscal year 2023, the Council provided a secondary

review of 762 grant applications in response to 35 SAMHSA/CMHS funding announcements. Council Members also had an opportunity to participate in discussions regarding SAMHSA Leadership updates, Certified Community Behavioral Health Clinic (CCBHC), School Based Mental Health Services, Mental Health Block Grant, Black Youth Suicide Prevention Activities, CMHS Response to Disasters, Transitional Age Youth Policy Academy, Potential Innovation, Olmstead Activity, Recovery Office, and Advisory Committee for Women's Services/SAMHSA Implementation of National Plan to End Gender-Based Violence.

20b. How does the Committee balance its membership?

The CMHS National Advisory Council is comprised of 12 members who are appointed by the Secretary, HHS. At least half will have a medical degree, doctoral degree in psychology, or an advanced degree in nursing or social work from an accredited graduate school or be a certified physician assistant; and shall specialize in the mental health field. Nine (9) members shall be from among the leading representatives of the health disciplines (including public health and behavioral and social sciences), relevant to the activities of CMHS; and three (3) members shall be from the general public and shall include leaders in the fields of public policy, public relations, law, health policy economics, or management. All 12 appointed members shall serve as Special Government Employees. The Council also includes seven non-voting ex-officio members - the Secretary, HHS; the Assistant Secretary for Mental Health and Substance Use, SAMHSA; the Director, Center for Mental Health Services, Director, National Institute of Mental Health; and the Under Secretary for Health of the

Department of Veterans Affairs; the Assistant Secretary for Defense for Health Affairs (or the designates of such officers) and the Chief Medical Officer, SAMHSA. Appointments are made paying close attention to experience and expertise as well as equitable gender representation, race/ethnicity representation, and geographic distribution. All Council members fully participate in policy and program development, each bringing to bear their unique perspective from their area of expertise.

20c. How frequent and relevant are the Committee Meetings?

Due to the Council's mandated function to provide guidance to the Center regarding programmatic policies and priorities, the Council met twice in person in fiscal year 2023. The Council reviews grant applications and recommends approval for projects that show promise of making valuable contributions to the Center's mission. The Council participated in ten online Electronic Council Book sessions to conduct second level grant reviews.

The 4/25/23 meeting included: Updates, and Appreciation from SAMHSA's Assistant Secretary, Consideration of the August 18, 2022, Meeting Minutes, CMHS Director's Report – Program Updates, Certified Community Behavioral Health Clinic (CCBHC), School Based Mental Health Services, Mental Health Block Grant, Black Youth Suicide Prevention Activities, CMHS Response to Disasters, and Public Comment. The 8/29/23 meeting included: SAMHSA Updates from Assistant Secretary, Consideration of the April 25, 2023, Meeting Minutes, CMHS Director's Report – Program Updates, Transitional Age Youth Policy Academy, Potential Innovation, Olmstead Activity, Recovery Office, Advisory Committee for Women's Services/SAMHSA Implementation of National Plan to End Gender-Based Violence, and

Public Comment. All these meetings were relevant to carry out the committee functions for FY 2023.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Council is composed of professional and public members who provide the second level of review for grant applications, as well as provide advice on all other aspects of the Center's activities relating to mental health services. The direction, scope, balance, and emphasis of the advice received from this group of experts cannot be obtained from Center or SAMHSA staff, or from other established sources, because the membership of the Council is uniquely constituted to meet the specific requirements of the statutory mission of the Advisory Council and of the Center.

Narrative Description

SAMHSA's mission is to lead public health and service delivery efforts that promote mental health, prevent substance misuse, and provide treatments and supports to foster recovery while ensuring equitable access and better outcomes. The CMHS National Advisory Council supports SAMHSA's mission by providing advice on issues and policies specifically related to the mental health of the Nation; the development and coordination of federal prevention

policies and programs; eliminating disparities in mental health services; making early mental health screening, assessment, and referral to services a common practice; advancing evidence-based practices; and developing and implementing health technology and tele-health systems to improve access and coordination for mental health care. SAMHSA is directed by Congress to target substance use and mental health services to people most in need, and to translate research in these areas more effectively and more rapidly into the general health care system. Over the years, SAMHSA has demonstrated that prevention works, treatment is effective, and people recover from mental and substance use disorders.

Behavioral health services improve health status and reduce health care and other costs to society. Continued improvement in the delivery and financing of prevention, treatment, and recovery support services provides a cost effective opportunity to advance and protect the Nation's health. SAMHSA's Center for Mental Health Services (CMHS) works to improve the quality of mental health services in America. In FY 2023, the CMHS National Advisory Council members participated in discussions regarding Certified Community Behavioral Health Clinic (CCBHC), School Based Mental Health Services, Mental Health Block Grant, Black Youth Suicide Prevention Activities, Transitional Age Youth Policy Academy, Potential Innovation, Olmstead Activity, Recovery Office, Advisory Committee for Women's Services/SAMHSA Implementation of National Plan to End Gender-Based Violence, and Updates from the Assistant Secretary.

Feedback is provided on subsequent committee meetings regarding pending issues and advised given.

During the life of the Council, approximately 70% of the recommendations have been implemented. Recommendations that have been implemented include promoting consumer awareness and peer support, inclusion of youth representatives, revision of the meeting formats, greater emphasis on services to children, and disaster preparation. Other recommendations included increasing the availability of quality measures in grant programs on access, disparities, populations served, and types of services provided in education, medical training, HBCU engagement, and workforce increases in mental health services.
