# 20a. How does the Committee accomplish its purpose?

The purposes of the Committee are to advise the Secretary of Agriculture on the administration of outreach and assistance for the Socially Disadvantaged Farmers and Ranchers and Veteran Farmers and Ranchers Competitive Grants Program (2501 Program); and additional ways USDA can continue building an inclusive future with targeted outreach and assistance to minority farmers and ranchers; and way to increase participation of these sectors in USDA programs.

# 20b. How does the Committee balance its membership?

The Committee is composed of 15 members and includes: not less than four socially disadvantaged farmers or ranchers; not less than two representatives of nonprofit organizations with a history of working with socially disadvantaged farmers or ranchers; not less than two civil rights professionals; and not less than two representatives of institutions of higher education with demonstrated experience working with socially disadvantaged farmers or ranchers.

Committee members serve a two-year term.

# 20c. How frequent and relevant are the Committee Meetings?

The estimated number of meetings per year are four (two face-to-face and two virtual meetings).

# 20d. Why can't the advice or information this committee provides be obtained elsewhere?

It is in the public interest for the Committee to remain active because, historically, socially disadvantaged farmers and ranchers have not had equal access to USDA programs, and this Committee is uniquely situated to facilitate and continue this critical dialogue where views and experiences among socially disadvantaged farmers and ranchers and USDA are exchanged. It is expected that these exchanges will result in quantifiably increased participation of socially disadvantaged farmers and ranchers in USDA programs, and positively impact the overall effectiveness and reach of these programs. This Committee also builds upon the Department's cultural transformation initiatives (e.g., equal access) and the critical strategic goal of equity.

#### 21. Remarks

The committee works in the interest of the public to ensure socially disadvantaged farmers have equal access to USDA programs and a new charge of capturing equity for those producers long excluded from full and meaningful participation in those programs. The Committee's chairperson did submit a list of declarative statements in a letter to the Secretary in FY 22 which have been received as recommendations. FY2023 recommendations produced 18 well developed with foundation and inputs from the agencies and includes advice on how to implement them in practical and meaningful ways.
