20a. How does the Committee accomplish its purpose?

The purpose of the Commission, as described in section 202 of the Veterans Access, Choice, and Accountability Act of 2014 (VACAA), is to examine the access of Veterans to health care from the Department of Veterans Affairs (VA) and strategically examine how best to organize the Veterans Health Administration (VHA), locate health care resources, and deliver health care to Veterans during the next 20 years. In undertaking this assessment, the Commission will evaluate and assess the results of the Independent Assessment conducted by CMS Alliance to Modernize Healthcare in accordance with section 201 of VACAA. The Commission will submit an interim report not later than 90 days after the initial meeting (September 2015) to the President, through the Secretary of Veterans Affairs; and a final report not later than 180 days after the initial meeting of the Commission.

20b. How does the Committee balance its membership?

Legislation specified the appointment authority by the President and Congress.

20c. How frequent and relevant are the Committee Meetings?

Estimated monthly meetings starting in September 2015. In FY 2016, the Commission held 11 meetings in various locations in Washington D.C. The meetings took place during the months of October 2015 (two meetings), November 2015, December 2015, January 2016, February 2016 (two meetings), March 2016, April 2016, May 2016, and June 2016.
