The purpose of the Council is to advise the Secretary of the Interior on matters relating to the Route 66 Corridor Preservation Program. The duties of the Council are solely advisory. The November 2008 meeting represented the last meeting of the advisory council which terminated when the Program sunsetted.

## 20b. How does the Committee balance its membership?

The National Park Service solicited nominations for membership on the committee from the entities specified in the Act, including state historic preservation offices, tribes, Route 66 associations, and other private and public individuals interested in Route 66.

## 20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Route 66 Corridor Preservation Act of 1999 (Act) instructed the National Park Service to provide technical, grant-making and cost-sharing support to public and private entities that are working to preserve Route 66 resources. These resources include the highway, adjacent structures, and other sites of interest that date from Route 66's period of outstanding historic significance (1926-1970). The Act authorizes the National Park Service to enter into cooperative agreements for the study, planning, preservation, rehabilitation and restoration of resources related to the Route 66 corridor. Additionally, the National Park Service must act as a clearinghouse for communication among entities interested in the preservation of the corridor.

## 20e. Why is it necessary to close and/or partially closed committee meetings?

All meeting are open to the public.

The Route 66 Federal Advisory Council terminates with the sunset of the Route 66 Corridor Preservation Act on August 10, 2009. Committee terminated August 10, 2009.
