**20a. How does the Committee accomplish its purpose?**

The Committee was established in 2001 to provide recommendations to the Secretary of the Interior and the Governor of California through the CALFED Policy Group, or its successor, on the implementation of the CALFED Bay-Delta Program (Program) as described in the Programmatic Record of Decision (ROD) signed August 28, 2000. On January 1, 2003, the California Bay-Delta Authority (Authority) was established by State legislation as the governing body for Program implementation, becoming the successor to the Policy Group. The purpose of the Committee was to provide recommendations on implementation of each element of the Program through the completion of Stage 1 (2000-2007) of

a 30-year program. The CALFED Bay-Delta Authorization Act (P.L. 108-361), signed into law on October 25, 2004, authorized Federal participation in the Program through 2010, extending the need for an advisory committee through that date. Sec. 104 of that Act reads &quot;In carrying out the Calfed Bay-Delta Program, the Federal agencies shall cooperate with local and tribal governments and the public through an advisory committee established in accordance with the Federal Advisory Committee Act...&quot; The Committee was supported by six Subcommittees -- Water Supply Reliability, Ecosystem Restoration, Water Quality, Levee System Integrity, Program Performance and Financing, and Steering Committee. These six Subcommittees advanced recommendations to the full Committee for discussion and consideration for recommendation to the 25 implementing agencies through the Secretary of the Interior. The Committee made recommendations on annual priorities and coordination of Program actions to achieve balanced implementation of the Program elements and on effective integration of Program elements to provide continuous, balanced improvement of Program objectives. The Committee provided input into the Annual Report on Program implementation and direction. The Secretary was required under the legislation to provide this Report to all Congressional authorizing and appropriating committees on behalf of those Federal CALFED agencies with responsibility for Program implementation. While the Committee has not met since June 2007, the Federal implementing agencies have continued to meet the statutory reporting requirements of P.L. 108-361 in coordination with the State.

**20b. How does the Committee balance its membership?**

Membership was made up of qualified representatives of Indian tribes and stakeholder groups, including environmental justice representatives. The 20 to 30 Committee member seats were selected based on experience and expertise in relevant fields, such as ecosystem restoration, agriculture, hydrology, urban water management, fishery biology, water quality, flood management, water conservation and recycling, affected by the health of the Bay-Delta.

Membership balance and diversity was reflected by the geographic diversity and interests of individuals who represent those affected by the health of the Bay-Delta. Membership dropped to 13 in 2008 with no plan to nominate new members, creating a void in representation of balance and diversity on the Committee.

**20c. How frequent and relevant are the Committee Meetings?**

The Committee generally held three full Committee public meetings annually and one joint meeting with the Authority, CALFED Program governing body. The Subcommittees met on a monthly or bimonthly basis as needed. In FY 08 the Committee was unable to meet, however the Subcommittees met on a less regular basis. This was due to other initiatives underway and endless meetings of the Governor's Delta Vision process to have a Vision and a Strategic Plan for the Delta completed by December 2008. This initiative, along with the Bay-Delta Conservation Plan, and the expiration of eight appointments, made getting a quorum for a full Committee meeting, or appointing new members, next to impossible as many of the same stakeholders were engaged in these other efforts. In FY 09 it became even more

difficult to keep focus on the CALFED Bay-Delta Program, so neither the Authority or the BDPAC held meetings.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

The CALFED Bay-Delta Program (Program) was an unprecedented effort to build a framework for managing California's most precious natural resource--water. Neither the State nor the Federal Government, acting alone, could accomplish the balanced, integrated implementation of the Program. Due to the unique purpose of the Committee, there was no other Federal advisory committee that could be tasked to perform the advisory functions of the Committee. Further, because of the nature of Program implementation and the need for numerous and frequent meetings of the Committee to advise the Secretary of the Interior, the use of public hearings was not practicable. In November 2009, the State Administration and State Legislature passed legislation creating a new governing structure for the Delta with broader responsibility than was under the CALFED umbrella. The need for the BDPAC as it was originally chartered is no longer relevant.

**20e. Why is it necessary to close and/or partially closed committee meetings?**

All Committee and Subcommittee meetings were open to the public and noticed by the State of California under State laws of noticing meetings. Full Committee meetings were noticed in the Federal Register.

**21. Remarks**

The California Legislature passed and the Governor signed legislation in November 2009

creating a new governing structure for the Delta, replacing the existing California Bay-Delta Authority, effective February 2010. Under this new governing body, the purpose for which BDPAC was created is no longer relevant and any need for a FACA committee in the future would take on an entirely different scope. BDPAC has not met since June 2007 nor is there any plan to nominate new members to maintain the balanced and diverse membership of the 20 to 30 member Committee.

### **Narrative Description**

The California Bay-Delta Public Advisory Committee provided recommendations to the implementing agencies through the Secretary of the Interior on implementation of the CALFED Bay-Delta Programmatic Record of Decision. In doing so the Committee made recommendations on effective integration of Program elements that provided continuous, balanced improvement in the areas of ecosystem restoration, water quality, levee system integrity, and water supply reliability. This supported protection of the Nation's natural resources using the best available science. The concepts of the CALFED Program supported and served as a model for the Department's Water for America initiatives. The Committee typically held four full Committee public meetings annually, while the Subcommittees met on a monthly or bimonthly basis as needed. In years 2007, 2008 and 2009, other initiatives and endless meetings took over, specifically the Governor's Delta Vision process to have a Vision and a Strategic Plan for the Delta completed by December 2008. This initiative, along with the Bay-Delta Conservation Plan, and the expiration of eight appointments, made getting a quorum for a full Committee meeting, or appointing new members, next to impossible as many of the same stakeholders were engaged in all three efforts. Much of the focus on the Delta and the State's water supply changed and new dynamics came into play changing the need for BDPAC as it was originally chartered.
