The Fifteen members represent (1) cities and towns bordering the Connecticut River and its tributaries, (2) State conservation or water quality agencies, (3) nonprofit conservation or citizens groups, (4) the Long Island Sound Management Conference, (5) energy and commerce interests associated with the Connecticut River, and (6) U.S. Fish and Wildlife Service.

### 20c. How frequent and relevant are the Committee Meetings?

Meetings occur based on need. No meetings were held in FY 03 because of need for governors to make recommendations of new members.

Meetings will be scheduled and held during the first half of Fiscal Year 2004.

### 20d. Why can't the advice or information this committee provides be obtained elsewhere?

The existence and composition of the Committee are mandated by Public Law 102-212. The Connecticut River watershed encompasses over 7.2 million acres in four states, and is home to over 2.3 million people living in 390 cities and towns. The Committee members represent the Service, states of Connecticut, Massachusetts, Vermont and New Hampshire, the cities and towns, and interest groups which depend on outreach and education. The Committee members were selected to provide important input and best represent the concerns of their constituences to the Conte Refuge Staff.

# 20e. Why is it necessary to close and/or partially closed committee meetings?

All meetings are open to the public.

#### 21. Remarks

Memberships on this committee have all expired. Since the Act requires that members be appointed based on recommendations by the governors of each of the four watershed states, the Service wrote to them in August 2000 requesting new appointments. Nominations have been received from the New Hampshire and Vermont governors. Connecticut and Massachusetts governors have not provided recommendations despite reminders

from Service staff.
