Meetings and Dates

Purpose Start To brief Committee members on the textile talks with the five Central American countries during the September 2003 round of U.S.-Central America Free Trade Agreement (CAFTA) negotiations. Key to the CAFTA is the successful conclusion of the textile negotiations. Advisors provided critical input to USG negotiators of the textile and apparel provisions. The advisors also received a de-brief on the WTO Cancun Ministerial. To discuss and provide advice on the activities of the Committee for the Implementation of Textile Agreements (CITA), including the China textile safeguard, commercial availability petitions, the Vietnam

bilateral textile agreement, and efforts by Customs and Border Protection to combat textile and apparel transshipment; the status of the selection of technologies for the textile marker system; the status of Free Trade Agreement (FTA) negotiations with Australia, Central America, the Southern African Customs Union; discussions with Sri Lanka on the Trade and Investment Framework

Agreement; an update on the Doha Round; and an update on the ISAC 15 subcommittee work to develop recommendations for streamlined paperwork requirements for textile and apparel trade preference programs.

20a. How does the Committee accomplish its purpose?

ISAC 15 provided advice to the Department of Commerce and to the United States Trade

Representative on a wide range of issues during the charter period. The committee was particularly active in issues regarding Free Trade Agreement (FTA) negotiations with Australia, Central America, the Dominican Republic and Morocco, and market access and compliance issues. The committee provided valuable input on negotiating positions for these negotiations, as well as FTA negotiations with the Southern African Customs Union. ISAC 15 members advised the interagency Committee for the Implementation of Textile Agreements (CITA) on trade negotiations including three China textile safeguard actions, transshipment issues, rules of origin, and commercial availability petitions. The Committee also continued its subcommittee work, to streamlining paperwork requirements for textile and apparel trade preference programs.

20b. How does the Committee balance its membership?

The membership of ISAC 15 is well-balanced geographically and also in terms of the number of industry sectors and viewpoints represented. Industry trade associations and individual companies are represented on the committee. The textile sector committee members include fiber producers, yarn spinners, fabric mills, fabric dyers and finishers, carpet mills, and household and industrial textile product manufacturers. The apparel sector members comprise outerwear, underwear, knitwear, and neckwear. The majority of companies represented manufacture domestically and most export their goods, while some include import operations. All of these segments of the industry bring different viewpoints on the international trade issues considered at committee meetings.

20c. How frequent and relevant are the Committee Meetings?

ISAC 15 meets three to six times a year. The actual number of meetings is determined by Government need for private sector advice and the consensus of the Committee regarding meeting frequency and dates. Members offer advice throughout the year at meetings, through phone calls, and by fax and letter. The advice the Government receives from the private sector through the advisory committee will be an on-going process and will be an intrinsic part of developing U.S. positions for all policy negotiations.

20d. Why can't the advice or information this committee provides be obtained elsewhere?

The Committee structure ensures a unique source of information to the Government. All members have security clearances and through a continuing dialogue with Government officials are made aware of Government trade policy at a level not otherwise available to the private sector. Because this Committee remains current in the broad spectrum of trade policy rather than a single facet--as would be the case in the absence of a committee structure--the private sector input from the committee is more pertinent. The advisory committee program, legislatively mandated, is the single formal comprehensive consultative link between the U.S. Government and U.S. industry and has the responsibility to address all issues concerning trade policy.

20e. Why is it necessary to close and/or partially closed committee meetings?

The Industry Consultations Program was established by the Trade Act of 1974 and in accordance with the Federal Advisory Committee

Act (FACA). Subsection 135(f) of the Trade Act provides that the ISACs shall be exempt from the provisions of the FACA relating to open meetings, public notice, public participation, and public availability of documents when it is determined that the proceedings would, if disclosed, seriously compromise the Government's negotiating objectives or bargaining positions regarding trade policy matters. ISAC meetings routinely involve these kinds of discussions. The United States Trade Representative (USTR) evaluates each meeting agenda and issues a Notice of Determination when it is necessary to close meetings.

Narrative Description

The Committee shall perform such functions and duties and prepare reports, as required by Section 135 of the Trade Act of 1974, as amended, with respect to the sector and functional advisory committees. The Committee advises the Secretary and the USTR concerning the trade matters referred to in Sections 101, 102, and 124 of the Trade Act of 1974, as amended; with respect to the operation of any agreement once entered into; and with respect to other matters arising in connection with the development, implementation, and administration of the trade policy of the United States including those matters referred to in Reorganization Plan Number 3 of 1979 and Executive Order 12188, and the priorities for actions thereunder. In particular, the Committee provides detailed policy and technical advice, information, and recommendations to the Secretary and the USTR regarding trade barriers and implementation of trade agreements negotiated under Sections 101 or 102 of the Trade Act of 1974, as amended, and Sections 1102 and 1103 of the 1988 Trade Act, which affect the products of its sector; advises the Committee for the Implementation of Textile Agreements on commercial availability petitions under Section 112(b)(5)(B) of the Trade and Development Act of 2000, and Section 211 of the Trade and Development Act of 2000, amending Section 213(b)(2)(A)(v)(II) of the Caribbean Basin Economic Recovery Act; Sections 1 and 6 of Executive Order No. 13191; and performs such other advisory functions relevant to U.S. trade policy as may be requested by the Secretary and the USTR or their designees.

ISAC 15 generally does not have a consensus view on textile and apparel trade issues. Under Section 135(e)(1) of the Trade Act of 1974 regarding any trade agreement entered into under section 2103(a) or (b) of the Trade Act of 2002, the Committee was required to provide the U.S. Trade Representative, the President, and Congress with reports on the U.S.-Australia Free Trade Agreement (FTA); the U.S.-Central America FTA; the

U.S.-Dominican Republic FTA; and the U.S.-Morocco FTA. The reports included an advisory committee opinion as to whether and to what extent the agreements promote the economic interests of the United States and achieve the applicable overall and principle negotiating objectives, and whether the agreements provide for equity and reciprocity within the textile and apparel area. These reports reflected diverse advisory opinions on the proposed Agreements.

Commerce internal procedures require that all responses for Secretarial signature (and/or joint signature with USTR) go through a concurrence process which ensures that the appropriate level Commerce officials are seeing the advice and have a chance for comment. All formal responses must be cleared by the Under Secretary of Commerce for International Trade prior to the Secretary's signature, which ensures that ISAC/IFAC advice is weighed and considered.
