### 20a. How does the Committee accomplish its purpose?

As mandated by Presidential Executive Order 13147, the Commission developed policy recommendations on CAM use that was provided to Congress and the President through the

Secretary of Health and Human Services. Commission meetings served as forums to review and discuss issues regarding coordinated CAM research efforts; access, delivery and reimbursement of CAM products and services; education, training and credentialing of CAM providers; and dissemination of CAM information to the public, which all fell under the broad scope of the Commission's mandate. The White House Commission on Complementary and Alternative Medicine completed deliberations and developed the Final Report that provided legislative and administrative recommendations for assuring that public policy maximizes the potential benefits to Americans of CAM therapies. The Commission, as required by Executive Order 13147, terminated on March 7, 2002. The Final Report was submitted to the Secretary of the Department of Health and Human Services on March 11. Secretary Thompson transmitted the Final report to the President and Congress on March 25. The report provided recommendations on the following issues: 1) Coordination of research; 2) Education and training of CAM and conventional Health Care Practitioners; 3) Development and dissemination of CAM information; 4) Access to and delivery of CAM practices and products; 5) Coverage and reimbursement for CAM practices and products; and 6) Coordination of Federal, state, and private sector activities.

**20b. How does the Committee balance its membership?**

The Commission consisted of 20 members appointed by the President. These members included representatives knowledgeable in health care practice and/or CAM from the public and private sectors.

**20c. How frequent and relevant are the Committee Meetings?**

The Commission held three meetings during this reporting period. One Town Hall meeting (01/23/02) was held to provide an opportunity for public testimony regarding complementary and alternative medicine.

**20d. Why can't the advice or information this committee provides be obtained elsewhere?**

The Commission's charge was to study and report on public policy issues in the rapidly expanding field of complementary and alternative medicine. These issues included training and credentialing, education of providers and the public, broadening of research efforts, and access to integrated health care. The recommendations addressed the education and training of health care practitioners; coordinated research to increase knowledge about CAM practices and products; reliable and useful information for health professionals that can be made readily accessible and understandable to the general public; and guidance for appropriate access and delivery of CAM. No current advisory committee could provide the necessary breadth and scope regarding all these policies.
